## THE CHARACTERS

**Waights Carlson McAllister**: Waights (67) is the family patriarch and co-owner of McAllister Zipper Company, which he and his brother, John, took over and grew from their father, Duncan. Following a large and unexpected offer for the company, the company was sold for a substantial amount of money. Waights now faces a new life, seeking a new identity or legacy for himself and the family.

**Martha Lynn McAllister**: Martha (64), a former nurse, is Waights' wife and confidant. She has steadfastly supported Waights through the years of both failures and successes of McAllister Zippers and has been involved in the life planning that followed the sale of the company.

**Charlotte Paige McAllister**: Charlotte (31) is the youngest child (only daughter) and a budding fashion designer in New York City. She leads a busy life designing from her "small" loft in Tribeca, marketing her designs and serving on several not-for-profit committees. Her friends and acquaintances range from socialites to artists to members of New York's fashion elite.

**Peter McAllister, M.D., Ph.D.**: Peter (38) is a professor and researcher at a prestigious medical school in North Carolina and shares his Mama's love of science. Peter had decided not to work in the family business. He is very fulfilled by his work and deeply committed to making a significant impact, in some way, in the medical/scientific community.

**Lloyd McAllister**: Lloyd (41) is the oldest child and moved back home from Atlanta to join the family business as general counsel. While zippers were not Lloyd's passion, he worked hard and felt that when the time came, he would naturally run the company when his father and Uncle John were ready to retire. Since the sale, Lloyd is exploring new options in real estate development.

## **BACKGROUND & SCENE**

Waights and his younger brother, John, took over the family business, McAllister Zipper Company, from their father Duncan. Over the years, they grew the company to become an "international contender" expanding their clientele beyond the U.S.

After Lloyd finished law school in Georgia, he began working for a local law firm, got married and settled down in Atlanta. With some urging from his father and "promises" that someday he would take over the business, Lloyd moved back to North Carolina with his young family in order to work for the family business. He and his wife, Cate, have a young son with Downs Syndrome.
